BUSINESS LICENSE FEE

A Business License is required by any entity (individuals, corporations, LLCs licensed individuals, financial service companies, etc.) doing business within the City of Hermosa Beach. Each location within the City will be considered a separate entity.

The fee for a Business License includes the first 2 employees/rental units

Category A

Businesses whose goods and services are subjected to State of California Sales Tax for at <u>least FIFTY (51%) of gross revenue</u>

\$200/ year plus \$25/year for each employee Cap 25 employees *for businesses with less than 4000 sq.ft.*

Category B

Business whose goods and services that DO NOT MEET INCLUSION OF Category A \$300/year plus \$25 for each employee/or rental unit. (Cap 25 employees for business under 5000sq ft.). Residents of Hermosa Beach will receive a \$100 RESIDENT CREDIT for Home Based Business.

Category C (cap includes employees)

- 1. Business with State of California Alcohol License for beer and wine only: Category A PLUS **0.0015**% of gross revenue greater than \$100,000/year <u>cap \$1150</u>
- 2. Business with Full Liquor License State of California: Category A fees PLUS **0.0015**% of gross revenue greater than \$100,000/year <u>cap of \$2000</u>.
- 3. Business with Alcohol License of State of California AND who either have a <u>cover</u> <u>charge or live entertainment</u>: Category A fees PLUS **0.0015**% of gross revenue greater than 100,000/year *cap of \$2500*
- 4. Any Category C business with operational hours after MIDNIGHT: Category A fees PLUS **0.0015**% of gross revenue greater than \$100,000/year <u>cap of \$4000</u>
- 5. Business with State of California Resale License for Alcohol: Category A fees PLUS **0.002**% of gross revenue greater than \$100.000/year <u>from alcohol related sales</u> cap \$4000

Category D \$150/year additional for any business selling tobacco products Category E

Disabled Veterans with greater than 50% service connected disability, with a business NOT in Category C, \$100 Business License Fee plus \$25 employee with same Cap as Category A.

Non-profits /Charities domiciled in Hermosa Beach, \$25/year registration fee, with wavier of Business License *Fee plus \$25 employee with same Cap as Category A*

Category F

Business domiciled outside of Hermosa Beach, Delivery Services, Motion Picture Production, Taxi/Auto for hire, Alarm Monitor Services, and public Utilities and others subjected to a Franchise Fee, will obtain a business license, but be exempt from employee charges.

Category G. Vacation Rentals (see attached)

Category H. Optional Annual Resident/Business owner fee of \$100/year, to allow day work on said property without obtaining Business License by service.

REVENUE COLLECTED ANNUALLY, ADJUSTED FOR LA COUNTY CPI, GREATER THAN \$800,000/year, 100% WILL BE ALLOCATED TO THESEWER FUND FOR INFRASTRUCTURE ONLY, WITHOUT THE ABILITY FOR THE CITY TO SWEEP FUNDS TO THE GENERAL OR OTHER FUNDS.

Since the expected 2011 sales tax, revenue is projected to be .877 of index year, revenue of \$374,234 from these categories.

Total Proposed Alcohol related Caps 147,000. This with sales tax revenue is 1,428/day.

What is the cost to the community for services provided related to this industry? 60% of a police shift is diverted, plus maintenance, etc.

The City manager stated that 3/5 of police on one shift are scheduled to patrol these businesses. This equates to 0.198 of total Page 1 of 2

police expenses, or \$2,084,890/yr or 5,712/day. Should the community be subsidizing this? Should the Taverns/Bars/Restaurants/Vendors that cause the City to spend \$4,284/day, greater than revenue the City receives, in security services be required to have there own patrol with a licensed security company, thus allowing the police to patrol the City?
