On July 25, 2013 we requested:

The written crime reports or incident reports for all Part 1 Rapes recorded in the City of Hermosa Beach, for each of the following years, 2008, 2009, 2010, 2011 and 2012.

(Part 1 - Forcible rape - is the carnal knowledge of a female forcibly and against her will. Rapes by force and attempts or assaults to rape regardless of the age of the victim are included. Statutory offenses (no force used—victim under age of consent) are excluded.)

On September 25 the HBPD provided 21 reports totaling 55 pages. Everything the HBPD provided is attached herewith.

The redaction was done by the HBPD. To minimize the amount of time required to do the redaction, only the main pages of each report were provided.

The handwritten notations giving the approximate locations of the incidents and the ages of the victims were added by the HBPD.

The HBPD has not yet provided the reports for 2008 and 2009.



told me that she was staying at the Crown Plaza in Redondo Beach (300 N Harbor Drive) with her friends in room. She said that they were getting ready to go out to the bars in Hermosa. While getting ready she told me that she consumed three shots of Vodka between the time of 2230 and 2300 on 3-14-10 and said that she and her friends took a cab from the Crown Plaza Hotel at about 2305 hours and arrived downtown Hermosa at about 2315 hours. She said that they went right to Sharkeez (52 Pier Plaza). Once inside she consumed two beers and one more shot. The told me that all she remembers was sitting at the bar, then getting up going to the restroom and then returning to the bar. The heavy she had, was when she woke up naked, next to a WMA, in a small apartment. She said she saw that her clothes were on the floor next to the bed and noticed that it was about 0830 am. She said the WMA about 20 to 25 years old was in his underwear lying next to her. As she was getting dressed she asked him what his name was and he said (NFD,NFI). She then asked him if they had sex and he said, "No". As they where talking she smelled vomit and she asked him if she had vomited and he told her that she had. When she was

they arrived at Café Boogaloo, said that the doorman at the club would not let them in because the bar was closing in a few minutes. The said that the members an unknown male telling the doorman "let them in". Told me that it might have been the bartender from Ocean Bar who said that but she is not positive. I asked the said if she noticed if anybody was following them as they were walking to each bar but she told me that she couldn't remember.

While inside Café Boogaloo, the bar and talking to the bartender from Ocean Bar and one of his friends but she can't remembers being inside the bar and talking to the bartender from Ocean Bar and one of his friends but she can't remember what the conversation consisted of. While inside the bar she remembers having 2 drinks but she can't recall what kind of drinks they were. Said she believes they were at the bar for approximately one hour, but her concept of time was probably impaired. The next image the property remembers is being inside a strange apartment talking to an unknown female about an unknown topic. The had no idea how she arrived at this apartment or who she was with. She stated that she had no idea how long she was inside the apartment or if she was sexually assaulted. She also can't recall if her friend the was inside the apartment with her.

The next thing remembers is waking up in bed the next day next to approximately 1000 hours. Neither girl could remember how they got home or any of the events that occurred after they were inside Café Boogaloo. told me that they didn't drive home because very faintly remembers being dropped off at her friend's apartment but she wasn't sure stated that both she and state felt horrible when they woke up. Both girls felt sick and were vomiting and had horrible headaches. told me that she has been hung-over from alcohol in the past but this was a different feeling than a normal hangover. I asked if she had any pain or discomfort in her vagina when she woke up and she told me she did not. She also said that it felt like her vagina had not been penetrated. Both girls tried to piece together the events of the previous night but neither one could remember anvthing after they entered into Café Boogaloo. said later on that day she eventually ended driving back home to Santa Ana. At this point didn't believe that any sexual assault had taken place. said she still was confused why she blacked out because she usually is very responsible when drinking alcohol. In total. remembers having 5 drinks. She also stated that she had a large dinner a few hours prior to drinking so her reaction to the alcohol was not normal.

On the evening of 01-02-11, the base discovered a red rash on her vagina. She had no idea where the rash came from or how she might have received it. It was then that she formed the conclusion that she might have possibly been drugged and raped. She feared that the rash might possibly have been an STD. I asked her if she had any injuries on her body and she stated that their was light bruising on her upper thigh and some slight scratches that were not there prior to the night of 01-01-11 The following day (01-03-11) first went to the "Planned Parenthood" and then to the hospital to get evaluated. It was at this time that she decided to call the HBPD to file a report. At the time this report was taken, said she still felt sick and that she was still vomiting.

told me that she is unsure if she was raped but she firmly believes that she was drugged by the bartender from Ocean Bar. She described the bartender as a male white adult in his mid to late 20's. He was approximately 5'11 and weighed between 160-180 pounds. He was wearing a v-neck white T-shirt and a pair of dark blue jeans and his hair was short and spiked. The described his friend as a male Hispanic or Latin, approximately 5'8 and he was wearing a hooded sweatshirt the same stold me that if she saw a picture of the bartender that she would be able to positively identify him.

I booked into evidence the sexual assault kit (tag # 6976) and the clothes was wearing the night of 01-01-11 (tag # 6975). It should be noted that the clothes have not been washed since the incident occurred.

She exclaimed "Whoa!" and the suspect immediately stopped penetrating her vagina. From the time she first noticed intercourse occurring to the time it stopped was approximately one second. Again, she did not know how long he had been penetrating her vagina prior to her awareness of it. She noticed that she was wearing her bra and blouse/dress from the previous evening; however she was not wearing her panties or black elastic pants. asked the suspect where she was. He told her she was at his residence. The suspect proceeded to tell her that he was friends with He had met her and the previous evening, and the two females returned to his residence. later left the location at an unspecified time. The suspect called left and she told him she was at Pedones Pizza (1332 Hermosa Ave). Although felt very confused, she did not recall feeling inebriated or sick. She remembered the suspect as being very friendly to her. The suspect recovered her underwear and pants from the floor for her. She redressed and left the suspect's residence within approximately five minutes of waking up. She then walked back to her car which was parked in the front parking lot of Mama D's. The suspect escorted her up to the area of Scotty's on The Strand (1100 The Strand); until she told him to stop escorting her. She walked the rest of the way to her car by herself. then drove herself to her friend residence (1 then drove her to the HBPD to file this report.

to her awareness of the act, she did not know if he continued penetrating her vagina after he went back to sleep,

and she never gave permission to the suspect to penetrate her vagina in anyway.

claimed that she never gave Suspect #1 permission to penetrate her body in any way, she did not approve of any sexual activity between him and her, she was not sure of the full extent of the sexual activity which occurred between her and the suspect (due to possibly having been drugged), and she is desirous of prosecution. Although she was certain that her vagina was penetrated on at least the above two occasions, she did not know if any other sexual activities occurred (such as oral copulation or anal penetration). She noticed discomfort in her vaginal region. She did not notice any discomfort in the area of her anus. She also claimed that she had started her period two days prior to this report, and that a tampon had been inside of her vagina prior to this incident. During our interview, she told me that she was unable to locate her tampon. She did not know if it had been removed, or if it had been pushed further inside of her.

Let told me that she lives in San Clemente, CA. On 8-18-12 at approximately 2230 hours, and three of her female friends (see the following) arrived in downtown Hermosa Beach. They entered American Junkie (68 Pier Avenue) shortly after arriving in Hermosa Beach. While inside of American Junkie, and drank three "Sailor Jerry" rum and Coke mixed alcoholic beverages as well as one shot of Jaeger Meister (alcoholic beverage). Between the approximate times of 0001 hours and 0030 hours, and her friend were approached by the suspect and his friend (see description of the suspect's friend later in this narrative). The suspect invited (see the friends behind at American Junkie and proceeded to Rein Sharkeez with the suspect and his friend.

The video also located a picture of two shadows hugging in an alley that were taken either by her or by him the stated, "I don't remember taking video or pictures of us. At the end of the video recording, it shows both of them arriving at the residence where they were greeted by dogs. Both of them continue to laugh, giggle, and make conversation about the dogs. Stated, "I don't remember anything. I just remember waking up at four in the morning and noticed that I was wearing an old red T-shirt of mine but with no undergarments. As I woke up, I noticed that I was alone in my bed and that my front door was wide open. As I stood up to close my door, I looked out the window and noticed that the Lexus was missing."

of them said no. At that point, when went back to sleep and a few hours later she woke up and went to work. Stated, "I was supposed to be at work at 730, but I was running late and made it at eight o'clock. Once at work, I felt off and sick. I just knew something was wrong, like if I had sex. After feeling sick, I went home and that's when I called you to report the car stolen." Refer to stolen vehicle report under DR#12-4-4-4 for further details and statements. The believes this unknown male subject left her house in between midnight and four (4AM) after they had sex, taking the keys to the Lexus that were sitting on top of her dining table and took the car without her permission.

The Lexus is a car she is taking care of for her friend at the time she arrived home from the bar.

When I asked why she had failed to mention this incident to me when I took the stolen report, she stated being embarrassed and was giving it some time to process all and for the vehicle to be located. After giving it some thought, she became worried about contracting a sexually transmitted disease (STD), and responded to Beach Cities Medical Center to receive STD testing. Once at the center, due to her not being conscious during the possible act of sexual intercourse, we were contacted to take a rape report.

At the time, was more concerned with contracting an STD than reporting the incident to the authorities. She claimed to be embarrassed and was unsure of being desirous of any prosecution stated, "I just want the car back".





I responded back to the SART center and was provided with the following items by SART as a SART kit, a SART urine sample, a SART blood sample, a SART forensic medical report, a bag containing clothing, and a bag containing a towel. I booked the above items into the HBPD property room (see attached property report for additional details).

SART and additionally told me that while performing the above examination on the state of the following: bruising on both of the victim's knees, bruising and tenderness on the victim's removearm, a Woods Lamp reaction on the victim's left hip (indicating possible saliva or semen contact on that area), no anal or vaginal tearing (although her interior vaginal walls were red and tender), and no toluidine blue dye uptake on the victim's vaginal or anal areas (indicating that there were no tears/abrasions in either of those two areas).

The above investigation was recorded with a digital audio recorder and the audio files were later downloaded into the HBPD computer system under corresponding date and time stamps.
