On 07-02-2005 at approx. 11:30pm personnel from E11, and A12 arrived at Dragon, 22 Pier Ave., Hermosa Beach CA in a response to a police request for an occupancy check.

Summary

On arrival I observed the patio of the establishment appeared to be over the occupancy load limits. I instructed fire department personnel to give me three (3) separate head counts on the patio and interior using mechanical counters. Resulting in an average count of 80 on the patio. The current occupant load is 46. The establishment did have a posted occupancy load certification of 46. I found them in violation of Section 2501.16.3 of the uniform fire code. Overcrowding and admittance of people beyond the approved capacity of a place of assembly is prohibited.

Issuance of the Citation

Jeff Bellandi identified himself as an owner was notified that the establishment was being cited and he accepted the citation and apologized for the inconvenience. Mr. Bellandi also reduced the occupancy numbers within the posted occupancy load during the time it took to complete the citation. Violations Observed
