On 12-04-2005 at approx. 12:03am personnel from E11 arrived at Blue 32, 1332 Hermosa Ave., Hermosa Beach CA and performed an occupancy check.

Summary

On arrival I observed the interior of the establishment appeared to be over occupancy load limits. I instructed fire department personnel to enter the business and give me three (3) separate head counts on the interior using mechanical counters. Resulting in an average count of 227. The current occupant load is 126. The establishment did have a posted occupancy load certification of 126 that was hanging in a visible location.

I found them in violation of Section 2501.16.3 of the uniform fire code and 103.4.4 UFC / 15-20.010 HBMC. Overcrowding and admittance of people beyond the approved capacity of an assembly and maintaining a hazardous condition.

Interior Inspection

Upon inspection the establishment had a high concentration of people throughout the business. Free movement was impeded, with aisles and means of egress obstructed.

Issuance of the Citation

Dave Lowe who identified himself as an owner was notified that the establishment was being cited. Mr. Lowe accepted the citation and apologized for the inconvenience. Mr. Lowe also reduced the occupancy numbers within the posted occupancy load during the time it took to complete the citation. He closed the business for the night.
