Narrative

Arrest: On 11-18-06 at approximately 0208 hours, I arrested [REDACTED] Canales, [REDACTED] Chavez, [REDACTED] Godinez, [REDACTED] Melendez, and [REDACTED] Tobias for violation of 836(a)(3) / 664 /211 PC, attempted robbery. The arrest occurred at the intersection of Longfellow Avenue and The Strand in the city of Hermosa Beach.

Details: On 11-18-06 at 0119 hours I (Droz) #173 was dispatched to [REDACTED] Hermosa Avenue regarding a 459 PC, burglary in progress. Upon my arrival all suspect(s) had left the scene. I contacted the victims, [REDACTED] K [REDACTED] and [REDACTED] P [REDACTED]. K [REDACTED] told me that unknown

suspect(s) had used a key to attempt to gain entry through the front door to his house. He prevented them from making entry and they left the area on foot heading northbound on Hermosa Avenue. He said there were approximately seven suspects and that they appeared to be young Hispanic males who had covered their faces with scarves and hoods.

I made a crime broadcast advising units of the above information. Within five minutes, Detective Cahalan #169 and Officer Smith found six subjects on the beach near Longfellow Avenue and The Strand. These subjects were detained for investigation, see supplemental report by Detective Cahalan.

I admonished K [redacted] and P [redacted] per the Simmons witness admonishment and then transported them to the intersection of Longfellow Avenue and The Strand. A field show up was conducted with the detained suspects. K [redacted] was positive that the suspect wearing the black shirt was the person who tried to unlock his front door. This suspect was later identified as [redacted] Canales. K [redacted] was also positive that the large male with the striped shirt was the person standing next to the suspect with the black shirt. This suspect was later identified as [redacted] Garcia. P [redacted] told me that she also recognized these two suspects.

After K [redacted] and P [redacted] identified the suspects, Detective Cahalan told me that Garcia was with [redacted] Godinez at the time he was detained, and that Canales was with [redacted] Chavez, [redacted] Melendez, and [redacted] Tobias when they were all detained at a separate location. Based on the positive identification of Canales and Garcia by K [redacted], the other suspects being in their presence when they were detained, and the number of suspects detained matching the approximate number of suspects observed at the time of the crime, I determined that all of the detained suspects were involved in the above crime. The circumstances surrounding the crime indicated that a coordinated group effort was used to gain access to the victim's residence, access was attempted by using a key to provide fast entry, the amount of suspects would have enabled the group to overpower the victims, and all of the suspects concealed their appearance with clothing or scarves. These details are consistent with execution of a home invasion robbery. Because I believed that these suspects intended to commit a home invasion robbery, I arrested them for violation of 836(a)(3) / 664 / 211 PC, attempted robbery. All suspects were then transported the HBPD jail.

I then transported K [redacted] and P [redacted] back to their residence. Officer Kansaku #161 interviewed [redacted] P [redacted], see attached supplemental report. I interviewed K [redacted] and he told me the following.

K [redacted] and his live-in girlfriend, P [redacted], were inside of his bedroom which is located near the front door to the residence. They were preparing to go to sleep. All of the lights were off and they were lying in bed. K [redacted] heard what sounded like a key unlocking his front door. He proceeded to his front door and saw that the deadbolt knob was starting to turn toward the unlocked position. K [redacted] grabbed the knob and prevented it from turning. He looked through the door's peephole and saw two males. He was unable to clearly see their faces, but remembered one male dressed in all black who appeared to be manipulating a door key. Another taller male was standing next to the first suspect, and this taller male covered the peephole with his hand. Prior to the peephole being covered, K [redacted] observed two more male suspects standing on 30th Street, behind the two suspects who were trying to gain entry. K [redacted] struggled to keep the deadbolt from unlocking for approximately three minutes. During this struggle, P [redacted] handed him a

telephone and he called the police. The suspects then left the front door area. The peephole was now uncovered and K observed four males walking northbound on Hermosa Avenue. P told him that she might have counted seven suspects during the incident.

K does not know the suspects that he identified in the field show up and he does not know how anyone would have acquired a key to his front door. He told me that the last person who he gave a key to was his ex-girlfriend, G FWA 40 years old, but she had returned the key approximately two months ago. K and P are desirous of prosecution.

I checked the front door to the residence and did not see any signs of damage. I then checked the surrounding area for evidence and did not find any. Officer Sullivan #170 did a wider area check for evidence along Hermosa Avenue which produced negative results.

Narrative

Details: On 11-18-06 at approximately 0900 hrs, I received a call from Detective Sgt. Heard informing me that there were six suspects in custody essentially for an attempt home invasion robbery. I arrived at the HYPD station a few minutes later and began my investigation. The following is essentially the results of my investigation:

Summary: I initially read the main reports and all supplementals, which in summary, stated that the victim heard a noise at his front door, looked through the peephole and saw about four M/H/A's standing at his front door, heard a key turn the lock, and called the police. His female friend informed the victim that there was up-to seven M/H/A's outside his front door. The police arrived shortly there after and six suspects were arrested.

Interviews: I spoke to victim [REDACTED] K [REDACTED] who essentially told me the following: K [REDACTED] said that he had just broken-up with his girlfriend of two and a half years [REDACTED] L [REDACTED], and said she was the only person who had a key to his home. K [REDACTED] said he did not see her outside his home but strongly believed she was involved somehow.

Detective Saylor and I interviewed suspect [REDACTED] Canales, who essentially told me the following: Canales said that he and his friends (the other in custodies) left a party in Santa Monica, bought some beer, and were coming to Hermosa to drink it on the beach. Canales said while they were all together in Hermosa "Some white lady came up to use and asked for some help." Canales said that she had a key and said she just saw her boyfriend/husband go into [REDACTED] Hermosa Avenue with another girl. Canales said that he could hear a male and female voices coming from the location. Canales said the "white lady" ask them to stand by while she went in side the home and retrieved some of her things. Canales said, " It sounded like a real story", and thought L [REDACTED] story was credible, so they agreed to help. Canales said that she attempted a few times to get into the home using the key but could not open the door. Canales said some of his friends thought the lock had been changed, but he said he thought someone was on the other side of the door blocking their entrance. After a few attempts all parties walked away. Canales said they then heard the sounds of police cars approaching, got scared, and ran.
