Hermosa Beach Police Department Crime / Arrest Report 245(a)(1) PQ ADW, et al DR 06-4437

Arrest: On 12/15/06 at about 0110 hours, I arrested Jason N. Ierien 10/7/83 for 245(a)(1) PC assault with a deadly weapon, 415(1) PC fighting, 594(a)(2) PC vandalism, and 647(f) PC public intoxication. The arrest occurred at 1332 Hermosa Avenue, Pedone's Pizza restaurant.

Details: On 12/15/06 at 0059 hours, I was working uniform patrol in a marked black and white police vehicle. I was parked, and standing outside my vehicle in the 1300 block of Hermosa Avenue monitoring pedestrian and vehicle traffic. I was flagged down by Witness 1 who stated there was a fight in progress inside Pedone's Pizza restaurant.

I responded to the location and advised dispatch of the situation. I looked inside the restaurant and saw four subjects on the floor all engaged in a physical fight and struggle with one another. I announced my presence and ordered them to stop fighting or they would be tased, referring to my Taser. The suspects stopped and layed on the ground as instructed.

IP Saazar was detained at the scene and ultimately arrested for his involvement in the fight, see arrest report DR 06-4438.

Narrative

I ordered Suspect lerien to his feet and instructed him to place his hands behind his back with his palms facing each other. I intended to handcuff and detain him pending my investigation into his involvement. Ierien stood and cupped his hands together behind his back. I ordered him again and Ierien responded that he was, "on my side." I grabbed hold of Ierien's arms to direct him into the proper position. Ierien yelled, "what the fuck you gonna do, I know Jon Sibbald, I train in Lotar!" Simultaneously, Ierien tensed his arms and began to pull away from my grasp.

lerien's statement and actions caused me great concern for my safety. I recognized Lotar as a martial art, and distinct form of hand to hand fighting. I did not want lerien to get a position of advantage where he could flee and/or assault me, so I pinned him against a table with the assistance of Officers Brunn and Droz. I locked lerien's right arm behind his back so that Officer Droz could handcuff him. Officer Brunn had hold of his left arm. All the while lerien was trying to stand up and wrestle free of our grasp. Officer Brunn then sprayed lerien in the face with a one to two second burst of his OC spray. lerien was handcuffed and seated in the back seat of a police vehicle. During thy contact with lerien I noticed the strong odor of alcohol emitting from his breath/person.

I contacted Witness Lease who essentially stated the following. He was in the restaurant when he noticed a verbal argument between lerien, Salazar, and Victim Bessel. All the subjects were seated at a table, the argument ended, so he thought nothing was going to happen. A short while later, Lease turned around and saw all three subjects in a fight on the ground. He tried to stop the fight by grabbing hold of them. He saw lerien put Bessel in a headlock and throw him to the ground.

I contacted Victim B who essentially stated the following. He was sitting in the restaurant when Suspect lerien approached him and said, "You're an asshole." B said he wanted to go home and was just trying to get something to eat. The next thing he knew, lerien put him in a headlock and threw him to the ground.

I looked at Beautiful and saw a golf ball size knot on the top, left side of his head. Beautiful complained of severe pain associated with the injury. HBFD paramedics administered medical aid, however Beautiful signed an AMA waiver.

Officer Lobue photographed Beauty injury. The photos were downloaded to the watch commander's computer.

I contacted Witness B who essentially stated the following. She was working inside the restaurant when all the subjects began fighting. She remembered lerien coming inside and being verbally belligerent and the "instigator" in the incident. She described his actions as "looking for a fight." She also said it was easily apparent that lerien was heavily intoxicated. lerien got into a verbal argument with the other subjects, but the argument ended. She thought it was over, however they all began fighting. She was unable to say what the content of the argument was.

During the field investigation, lerien damaged the rear window of a police vehicle, see supplemental report.

Summary Narrative

ASSIGNMENT/ARRIVAL

On 12-15-06 at about 0059 hours, I responded to 1322 Hermosa Avenue in regards to a large fight that was in progress. Officer Kansaku was on scene and was requesting additional assistance. Upon arrival, I along with other units who had arrived on scene entered Pedones restaurant to assist Kansaku. At this time, I observed Kansaku attempting to arrest a combative subject. I saw a handcuffed subject lying on the floor. Officers Brunn and Droz assisted Kansaku in placing the combative suspect under arrest. At this point, I took custody of the suspect that was on the ground and removed him from the restaurant and placed him into the rear of a police unit that was parked outside of the location. Moments later, Kansaku, Brunn and Droz exited the restaurant with the combative suspect and placed him in the rear seat of a patrol unit (HB#6) that was parked on Hermosa Avenue in front of the location. The doors of the police unit were closed and locked with the windows rolled up after the suspect was secured. I observed that the suspect was yelling obscenities and attempting to pull away from the officers hold prior to them placing him into the patrol unit.

At this time, I was standing approximately ten feet away from the police unit where the suspect was detained when suddenly I saw the back right rear passenger side window of the police unit explode. Glass from the window flew outward away from the police car and littered the street and the sidewalk on the East side of Hermosa Avenue. I saw that the suspect was laying on his back and that his feet and legs were positioned against the right rear window. It should be noted that there was no other persons around the police unit when the window was broke out. At this point, I ran to the police unit. Officer's Droz, Sellan, Brunn and Kansaku removed the suspect from the vehicle. The suspect was jerking his body and kicking at the officers. Myself, along with other officers were ultimately able to control the suspect by placing him in a Hobble Restraint. The suspect was then transported to the Hermosa Beach Police Department.
