On 12-15-06 at 0125 hours I (Droz) #173 was dispatched to 1042 The Strand regarding a 211 PC robbery that had just occurred. While proceeding to that location I was flagged down by the victim, at the intersection of Hermosa Avenue and Pier Avenue. Method me the following.

Sprite Motel, 1042 The Strand, when they were confronted by two males. Suspect #1 approached Managed a small (3 inch blade) knife, and said, "You can either give me your wallet or I can stab you." This threat caused Managed to fear for his safety. Managed then your wallet or I can stab you." This threat caused Managed to fear for his safety. Managed then your wallet and then threw it down on the ground.

Suspect #2 never made any contact with either the victim or witness. Suspect #2 stayed a short distance away from the activity and seemed to have been used to intimidate the victim into cooperation.

Suspect #1 and Suspect #2 then walked northbound on The Strand at a slow speed.

Manual then recovered his wallet and notified police dispatch of the robbery. Minus and his friend, American France then proceeded to the intersection of Hermosa Avenue and Pier Avenue to flag down responding HBPD units.

Neither Media or Feed were injured during the robbery. They do not know who the suspects are, but would be able to identify them. Media is desirous of prosecution. He claims that approximately \$100.00 dollars in twenty dollar bills were stolen from his wallet.

I then interviewed F. F. said she was standing next to Manual at the time of the robbery. No property was taken from her. From then gave me a detailed description of the two suspects. See suspect page.

HBPD units conducted an area check for the suspects with negative results. At approximately 0230 hours Market contacted police dispatch and informed them that he had just seen the suspects at the intersection of 15 Street and The Strand. HBPD units immediately conducted an area check, which also produced negative results.

At 0246 hours another 211 PC robbery occurred at 817 Bayview Drive. The circumstances of both robberies are similar. Unknown suspect(s) used a possible weapon to gain possession of the victim's wallet. It's unknown if these incidents are related. See DR# 06-4440.
