Narrative

On 12-15-06 at 1603 hours I (Droz) #173 was driving northbound in the 1100 Block of The Strand. While approaching the public restroom facility that is located at this location, I discovered damage that had been inflicted upon several of its restroom doors.

Upon further investigation I discovered that five of the restroom stalls on the south side of the public restroom building had been vandalized. Starting from the east side of the building, the first six restroom doors had sustained damage to their lower ventilation screens. The mesh backings behind these screens were also damaged.

Starting from the east side of the building, graffiti was also found inside of the #1 stall, the #2 stall, the #3 stall, the #4 stall, the #7 stall, and on the outside of the southwest corner of the building. The graffiti on the southwest corner of the building stated "ICEK EXCEL 23 HERO."

No one had permission from the City of Hermosa Beach to damage this city property. I was unable to locate any witnesses to this crime. It is uncertain exactly when this crime occurred.

Sergeant Thompson # 078 photographed the crime scene and downloaded these photographs into the HBPD computer system.
