Narrative

On 12-30-06 at 0008 hours I (Droz) #173 was dispatched to The Dragon Bar, 22 Pier Plaza, regarding a 415(2) PC fight that had just occurred. I arrived at the above location and located two victims, Alberta Market and Salar had been attacked by multiple subjects. I contacted Market and she told me the following.

Many said that she was inside of The Dragon Bar. A verbal argument ensued between her and her sister, which was her sister's ex-boyfsiend. She was unable to give any description or additional information regarding House. Many was unable to give a detailed description of the events surrounding this incident and appeared to be under the influence of alcohol. Many said that she was not desirous of prosecution against which Many.

Beach Fire Department for injuries sustained during a fight which was related to the above incident. See was incoherent and not responsive to questioning, and appeared to be under the influence of alcohol. He did not give a statement. See was transported by HBFD to Harbor General Hospital.

I then contacted a witness to the incident, Manner, and he told me the following. More is a doorman at Hennessey's Tavern, 8 Pier Plaza. He was standing near the front door of the above location and saw a fight erupt in the front patio area of The Dragon Bar. Two subjects who had been involved in the fight walked to the opposite side of Pier Plaza and contacted the subject which was later identified as Manner. One of these subjects was a Hispanic male wearing a dark shirt and the other was a thin Caucasian male wearing a white shirt. Maness then pointed to the victim who was later identified as Manner. Those two subjects attacked Sanner A third subject, described as a thin Caucasian male wearing a dark jacket, joined the fight and assisted them. Manner said these three subjects punched and kicked Sanner He believes that Sanner was kicked in the head by at least one subject. Sanner and his three attackers then moved their fight to the intersection of Pier Avenue and The Strand. The three attackers left the area, possibly traveling toward the parking structure at 1301 Hermosa Avenue. More does not know the identity of the three suspects.

I then contacted a second witness, the Boundard Boundard

identity of the suspects.

On 12-30-06 at approximately 0300 hours I contacted Harbor General Hospital, 1000 W. Carson Street, Torrance, CA, and interviewed Nurse France by telephone. France told me that Swar was in stable condition and sustained a "through and through laceration" to his lip. He also appeared to be under the influence of alcohol. She said that his injuries were not life threatening and that she expected him to be released from the hospital within twenty-four hours.
