then told the suspect, "Calm down, he didn't do anything." yelled, "Get away from then proceeded to leave the area. He did not sustain any physical injuries from this described his attacker as an African-American male wearing a light colored jacket, refer to suspect page for additional description.

described his birthday cake as a single layer chocolate cake which was approximately two feet by two feet wide, and which cost approximately \$190.00 dollars. He is desirous of prosecution against and for stealing his birthday cake and is desirous of prosecution against his unidentified attacker for assaulting him.

It should be noted that several members of the Los Angeles Lakers basketball team, including the above mentioned subjects, had patronized Blue 32 during the hours prior to the above incident. Blue 32 has interior surveillance cameras that could have potentially filmed unknown attacker.
