On 02/05/07 at approximately 2001 hours, I was dispatched to the 2300 block of The Strand regarding an attempt robbery that had just occurred approximately six minutes prior. Dispatched advised that three males had attempt to rob the victim and then fled eastbound on 23rd Street. Sgt. Saldana and Officer Higgins checked the area and I contacted the victim. I contacted victim who stated the following;

stated that he was on a walk northbound. The Strand when he was surprised by three unknown subjects that were walking southbound towards him. The subjects walked up to and two of the subjects, now S1 and S2, said, "What do you have in your pockets". was startled by the question. S1 and S2 then got even closer to him and started grabbing at his pockets in his jacket and his pants. While they were grabbing at his pockets they repeatedly said something to the affect of, "Give me your wallet/ money. Where is your wallet/money" The victim was unsure of what they actually said because he was scared of what the suspects where going to do to him. As the suspects where searching his pockets, began to walk backwards away from them and became so scared that he began to yell "Help" as loud as he could several times. As he yelled the three suspects ran eastbound 23rd Street, then stated he ran to 23 The Strand for help. The suspects were unsuccessful described S1 as a MWJ 15-16 yrs old 5-07 120 NFD. in getting any property from the last and white tennis shoes. S2 was described as a MHJ 15-17 yrs old 5-05 160 lbs wearing dark sweat shirt and dark pants. S3 was described as a MHJ 15-17 yrs old 5-05 yrs old 130lbs wearing all dark clothing.

proached me asking if I was in the area looking for some young trouble makers. Although he did not witness the attempt robbery on Leading, he observed the suspects just prior at approximately 2700 The Strand. Stated when he observed the subjects he got a very uneasy feeling and thought the three subjects were going to do something to him. He believes because he had his dog with him they walked past him. gave a very similar if not exact description of the subjects as

Sgt. Saldana and Officer Higgins had detained three subjects at 24th Street and Palm that closely matched the description of the suspects. I admonished hd. show up admonishment and took them to the detained subjects with negative results.
