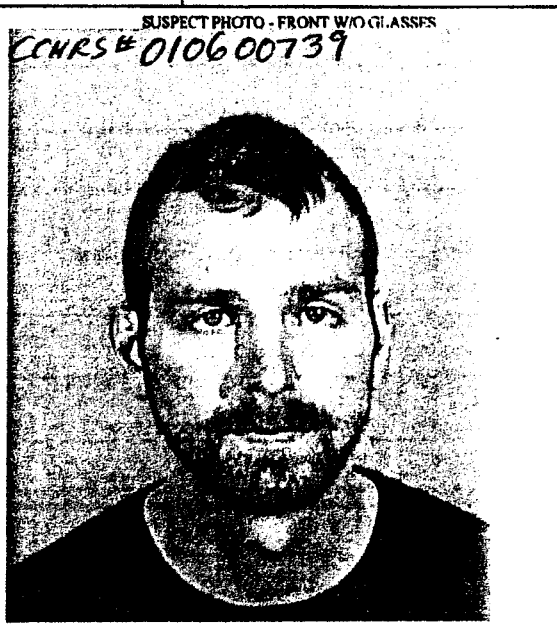

Summary Narrative

I explained and demonstrated a standardized battery of field sobriety tests to Dudick and he told me that he understood all instructions and demonstrations given to him. I documented an approximation of those SFST's on the DUI face sheet of this report.

ARREST

Based upon the totality of my training, observations and investigation, I formed the opinion that Dudick was under the influence of an alcoholic beverage and was unable to operate a motor vehicle safely. I placed Dudick under arrest for suspicion of driving under the influence of an alcoholic beverage, CVC 23152(a).

CHEMICAL TEST ADMONITION

I admonished Dudick of his chemical test requirements and he selected the breath test. I transported Dudick to the Hermosa Beach Police Department where he submitted to a breath test with results of .18% and .17%, see attached.

BOOKING

Dudick was booked at the Hermosa Beach Police Department for violation of CVC section 23152(a) - Driving under the influence of an alcoholic beverage. Due to the fact that Dudick's BAC was above .08%, I additionally charged him with CVC 23152(b) - Driving under the influence of alcohol with BAC .08 or higher.

Summary Narrative

PROBABLE CAUSE FOR TRAFFIC STOP

On 12-09-2007 at about 2035 hours, I was traveling in the 1400 block of N/B Hermosa Avenue when I noticed that the vehicle directly in front of me was traveling above the posted speed limit. I continued to follow the vehicle N/B on Hermosa Avenue and paced its speed at about 38 miles per hour which is above the posted 30 mile per hour speed limit. As the vehicle traveled in the #2 lane in the 1900 block of Hermosa Avenue, I observed it swerve and come within feet of colliding into vehicles that were parked along the East curb line of Hermosa Avenue. At this point, I effected a traffic stop on the vehicle in the 2100 block of Hermosa Avenue for violation of CVC section 22350 - Speeding and to investigate the driving pattern that the driver displayed.

DRIVER CONTACT

I exited my patrol car and contacted the driver on the driver side of the vehicle by speaking to him through the open driver side window. I informed the driver of the reason why I had stopped him, speeding and swerving, and asked him for his driver license. The driver gave me a California driver license that identified him as [REDACTED] Dudick (DOB [REDACTED]). As I spoke to Dudick, I noticed that his eyes were bloodshot/watery. I asked Dudick if he had anything alcoholic to drink and he told me that he did. I checked Dudick's eyes for Horizontal Gaze Nystagmus and he checked positive for this objective symptom of alcohol intoxication. At this time, I formed the opinion that Dudick was possibly under the influence of an alcoholic beverage and instructed him to exit his vehicle so that I could administer further test, SFST.
