6	WHEREAS, a Special Municipal Election was held and conducted in the City of		
7	Hermosa Beach, California, on Tuesday, June 6, 2006, as required by law; and		
8	WHEREAS, notice of the election was given in time, form and manner a		
9	provided by law; voting precincts were properly established; election officers were appointed		

and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 06-6437 adopted January 10, 2006, the County Election Department canvassed the returns of the election and has certified the results to the City Council, the results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY HERMOSA BEACH, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That there were seventeen (17) voting precincts established in the City for the purpose of holding said election.

That the whole number of ballots cast in the precincts except absent voter ballots was 2,903, and the whole number of absent voter ballots cast in the City was 1,119, making a total of 4,022 ballots cast in the City.

SECTION 2. That the Special Municipal Election was held for the election of a Member of the City Council to fill a vacancy for an unexpired term ending in November 2009.

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the office for which the persons were candidates were as listed in the attached Exhibit "A."

SECTION 4. That the City Council does declare and determine that: **PATRICK "KIT" BOBKO** was elected as Member of the City Council for the unexpired term ending in November of 2009.

SECTION 5. That the City Clerk shall enter on the records of the City Council of the City a statement of the result of the election, showing: (a) the whole number of ballots cast in the City; (b) the names of the persons voted for; (c) the office each person was voted for; (d) the number of votes given at each precinct to each person; and (e) the total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver to the person elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to the person elected the Oath of Office prescribed in the Constitution of the State of California and shall have him subscribe to it and file it in the office of the City Clerk. The person so elected shall then be inducted into the office to which he has been elected.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original Resolutions.
