## Parks, Recreation and Community Resources Advisory Commission Subcommittee Descriptions

#### Friends of Parks

Creating Community Through People, Parks, and Programs: Hermosa Beach Friends of the Parks (FOP) is a 501 (c)(3) non-profit foundation dedicated to identifying, prioritizing and fundraising for park and recreation improvements throughout the City of Hermosa Beach. In addition, FOP promotes the use of Hermosa Beach parks to the community and promotes the parks as a valuable resource to the city's residents and visitors. Mission Statement: "Our mission is to preserve, improve and promote the use of Hermosa Beach parks and recreation programs for the benefit of the entire community."

#### **Hermosa Arts Foundation**

The mission of the Hermosa Arts Foundation is to promote the arts within the Hermosa Beach community and to provide for facility and equipment improvements at the Hermosa Beach Community Center. The Foundation will develop and facilitate educational, cultural, recreational and social programs for all citizens of Hermosa Beach.

## Hermosa Beach Historical Society

The Hermosa Beach Historical Society exists for the purpose of preserving and chronicling the history of Hermosa Beach. Established in 1987, its offices and the museum are located in the Hermosa Beach Community Center. The mission of the Hermosa Beach Historical Society is to acquire, preserve, and interpret historical memorabilia and other materials pertaining to the history of the City of Hermosa Beach. This collection shall be extended to the public as a source of delight, illumination, and lifelong learning.

#### Park Master Plan Committees

A park maser plan is a general guideline for appropriate park uses and their location within a specific park site. The plan serves as a long range vision (10-20 year time frame) for future development and programming. Issues typically addressed include planned park elements, natural and cultural resources management, and general design concerns. The plan is conceptual in nature. It serves to assist with the determination of the best uses for a specific site and optimize management of the site's resources. Public input is essential to the success of a park master plan. Park users identify needs, desires, and community issues. Typically, there are three meetings throughout the planning process to seek community involvement.

### Surfers Walk of Fame

Renowned surfers are annually inducted to the Hermosa Beach Surfers Walk of Fame. Brass plaques are installed in the pavement of the Pier.
